FACTORY AND WORKSHOP ACT, 1901.

The Secretary of State for the Home Department hereby gives notice, in pursuance of Section 80 of the Factory and Workshop Act, 1901, that he has amended the draft Regulations for the manufacture of celluloid and articles partly or wholly made of celluloid, which were issued in May, 1914, and that he proposes to make Regulations in accordance with the amended draft.

The Pirelli General Cable Works, Ltd., Western Shore, Southampton: Women of 18 and male young persons of 16 years of age and over employed on twinning and telephone machines and telephone stranding machines.

The Home Secretary gives notice, that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment of women and young persons of 18 years of age and over in minding lace-making machines at the works of The Shepshed Lace Manufacturing Co., Ltd., Peckwash Mill, Duffield, nr. Derby, on two day-shifts,

subject to the conditions that no worker shall be employed in the afternoon shift in consecutive weeks; that suitable cloakroom and messroom accommodation shall be provided; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.

BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

In the Matter of Georg Sylvester Schaeffer.
Revocation of Certificate of Naturalization.

And I further direct that Bertha Marie Emma Schaeffer, the Wife of the said Georg Sylvester Schaeffer, shall cease to be a British subject.

BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

In the Matter of Kurt Otto Blothner.
Revocation of Certificate of Naturalization.

And I further direct that the Wife of the said Kurt Otto Blothner shall cease to be a British subject.
