

to this Scheme or Representation from the close numbered 242 upon the same maps, and extending thence first north eastward along the fence forming the northern boundary of the said close numbered 242 and then south eastward along the fences forming the eastern boundaries of the said close numbered 242 and the close numbered 243 upon the said maps for a distance in all of 16 chains or thereabouts to the point where the last mentioned fence crosses the middle of Gloucester Road, and extending thence north eastward along the middle of Gloucester Road for a distance of $8\frac{1}{2}$ chains or thereabouts to the fence forming the north eastern boundary of the close numbered 240 upon the said maps (which close includes the surface of Gloucester Road and the houses abutting upon the south eastern side of it, Allen Road, Rock Road and other land), and extending thence first south eastward, then southward and then again south eastward along the last mentioned fence (which in part forms the eastern boundary of the houses and premises situate on the eastern side of Rock Road) for a distance of $10\frac{1}{2}$ chains or thereabouts to the point where such fence meets the northern side of Frome Road, and extending thence eastward in a straight line diagonally across Frome Road for a distance of $1\frac{1}{2}$ chains or thereabouts to the point on the southern side of Frome Road at the northern end of the fence forming the north eastern boundary of the close numbered 258 upon the said maps, and extending thence first south eastward along the last mentioned fence and then south westward along the fences forming the south eastern boundary of the said close numbered 258 and the southern boundary of the close numbered 367 upon the said maps for a distance in all of 25 chains or thereabouts to the point where the last mentioned fence meets the boundary which divides the said District Parish of the Holy Trinity, Trowbridge, from the said New Parish of Saint John, Studley."

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Salisbury.
