IMPORTATION OF PLUMAGE (No. 1)
ORDER, 1922.

DATED 25TH MARCH, 1922.

MADE BY THE BOARD OF TRADE.

The Board of Trade, in pursuance of the powers conferred upon them by Section 2, Sub-section 3, of the Importation of Plumage (Prohibition) Act, 1921 (11 and 12 Geo. 5, chapter 16), and of all other powers enabling them in

that behalf, having taken into consideration a recommendation made in the matter by the Advisory Committee appointed under Section 3 of the said Act, hereby make the following Order:—

1. This Order may be cited as the Importation of Plumage (No. 1) Order, 1922.

2. There shall be added to the Schedule to the said Act the name of the bird Rhea Rothschildi (Order Rheiformes).

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October, 1918, the Trade Board established under the Trade Boards Act, 1918, in Great Britain for the branches of Trade specified in the Trade Boards (Hair, Bass and Fibre) Order, 1919, HEREBY GIVE NOTICE, as required by Section 3 (5) of the Trade Boards Act, 1918, that they Propose to Vary the General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates at present fixed and set out in the Schedule to their Notice H.B. (6), dated 15th October, 1921, for Male and Female Workers, the proposed variations being as shown in the Schedule set out below.

The Minister of Labour has given his consent to the issue of this Notice.
