The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz. :-

REGULATIONS RESPECTING OPEN COMPETITIVE EXAMINATIONS FOR THE SITUATION OF IN-SPECTOR IN THE ENGINEER-IN-CHIEF'S DE-**PARTMENT OF THE GENERAL POST OFFICE.** 

N.B.—These Regulations are liable to alteration from time to time.

J. Age.—The limits of age for this situation are 17 and 20, with the proviso that in the case of examinations held within two years from the date of the first examination under this scheme the upper limit shall be 22. Candidates must be of the prescribed age on the 1st March or the 1st September of the year in which they are examined, according as the examination is held in the first or second half of the year.

In reckoning age for this purpose a candilate may deduct any time up to a maximum of two years which he has spent in His Majesty's Forces between 4th August, 1914, and 31st December, 1919.

2. Nationality.---No person will be eligible for appointment to the Civil Service who is not a natural-born British subject and the child of a father also a natural-born British subject; provided that exception may be made in the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners, and provided that exception may be made as regards the father in the case of candidates who served in His Majesty's Armed Forces during the Great War.

3. Health and Character.-Candidates must satisfy the Civil Service Commissioners as to their health and character.

4. Members of the Royal Irish Constabulary of less than five years' service are ineligible.

The following classes of persons are eligible under certain conditions only, that is to say :---

(a) Persons actually serving in the Army,

Navy or Air Force. (b) Persons holding situations in the Civil Service.

(c) Members of the Royal Irish Con-stabulary of more than five years' service.

(d) Apprentices in His Majesty's Dockvards.

(e) Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer.

No person actually serving in the Army, Navy or Air Force will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued.

Persons comprised in classes (b), (c), (d) must obtain the permission of the authorities of their Department to attend the examination before the commencement of the competition.

Persons comprised in class (e) will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Educational Authorities in Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

5. Subjects of Examination.-The examination will be in the following subjects :-

- 1. Pure Mathematics.
- 2. Applied Mathematics.
- 3. Heat, Electricity and Magnetism.
- 4. Engineering, Drawing and Design.
- 5. Either (a) Sound and Optics, or (b) Chemistry.
- 6. Personal Qualities.

The candidate must attain in each subject he offers such a standard as to satisfy the Civil Service Commissioners.

The examination may be held in one part or in two parts, at the discretion of the Civil Ser-In the latter case the vice Commissioners. first part of the examination will be used to reduce the number of competitors to be admitted to the second part. Of those who pass and obtain the highest aggregate marks on the first part a certain number, to be determined by the Civil Service Commissioners, will be admitted to the second part of the examina-The successful list will consist of those tion. candidates who pass and obtain the highest aggregate marks on the whole examination.

6. A pplications for permission to attend an Examination must be made at such time and in such manner as the Civil Service Commissioners may appoint.

7. Fee.-A fee of £2 will be required from every candidate attending an Examination.

The Civil Service Commissioners further give notice that an Open Competitive Examination will be held under the foregoing Regulations at Edinburgh, London and Manchester, commencing on the 13th July, 1922.

Not fewer than 10 Candidates will be declared successful on the result of this Examination, if so many should be found qualified.

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 8th June, an application, in the Candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.
