SPECIAL ACTS (EXTENSION OF TIME)
 ACT, 1915.

MINISTRY OF TRANSPORT ACT, 1919.

BY virtue and in pursuance of the provi-
 sions of the above-named Acts, the
 Minister of Transport hereby orders that the
 period limited for (a) the exercise of the
 powers for the compulsory purchase of lands
 to be acquired for the widening of the London
 and South Western Railway between Twicken-
 ham and Richmond authorised by the South
 Western Railway Act, 1913; (b) the comple-
 tion of the graving dock, sea walls or embank-
 ments and channel situate on the foreshore
 or mudlands and bed of the River Itchen or
 Southampton Water, in the Parish and Urban
 District of Itchen, in the County of Southamp-
 ton, authorised by the South Western Railway
 Act, 1909; (c) the exercise of the powers for
 the compulsory purchase of lands required for
 Railway No. 2, in the said Parish and Urban
 District of Itchen, and the Parish of Hound,
 in the County of Southampton, authorised by
 the South Western Railway Act, 1909, as ex-
 tended by the South Western Railway Act,
 1913; (d) the completion of the works of the
 Railway No. 2 before mentioned; and (e) the
 exercise of the power for the compulsory pur-
 chase of lands in the Parish and Urban Dis-
 trict of Itchen, to be acquired under the powers
 of the South Western Railway Act, 1913,
 shall be further extended in each case for one
 year from the 15th day of August, 1922.
