MOST GRACIOUS SOVEREIGN.

We, Your Majesty's most dutiful and loyal subjects, The Senators and Commons of Northern Ireland in Parliament assembled, having learnt of the passing of the Irish Free State Constitution Act, 1922, being the Act of Parliament for the ratification of the Articles of Agreement for a Treaty between Great Britain and Ireland, do, by this humble Address, pray Your Majesty that the powers of the Parliament and Government of the Irish Free State shall no longer extend to Northern Ireland.

To which Address His Majesty was pleased to give the following reply:—

I have received the Address presented to Me by both Houses of the Parliament of Northern Ireland, in pursuance of Article 12 of the Articles of Agreement set forth in the Schedule to the Irish Free State (Agreement) Act, 1922, and of Section 5 of the Irish Free State Constitution Act, 1922: and I have caused my Ministers and the Irish Free State Government to be so informed.
