THE FAIRS ACT, 1871. THE LOCAL GOVERNMENT ACT, 1894.

BURTON-ON-TRENT HORSE FAIR.

Whereas a representation has been duly made to me, as Secretary of State for the Home Department, by the Town Council of Burton-on-Trent, to the effect that it would be for the convenience and advantage of the public that the Horse Fair, which has been annually held on the 28th day of October, or, if that day be a Sunday, on the following day, at Burton-on-Trent in the county of Stafford, should be abolished:

And whereas notice of the said representation, and of the time when I would take the same into consideration, has been duly published, in pursuance of the Fairs Act, 1871:

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished:

Now, therefore, I, as Secretary of State for the Home Department, in exercise of the powers vested in me by the Fairs Act, 1871, do hereby order that the Horse Fair which has been annually held on the 28th day of October, or, if that day be a Sunday, on the following day, at Burton-on-Trent in the county of Stafford, shall be abolished.
