And We do by these Presents will and ordain that this Our Commission shall continue in full force and virtue, and that you, Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment; provided always that three years after the date hereof and every subsequent year thereafter two of your number shall retire from this Our Commission in such order as you shall determine and that to the places thereby made vacant there may be appointed by Warrant under Our Sign Manual such persons as We shall think fit so to appoint:

And We do further ordain that you have liberty to report to Us your proceedings under this Our Commission from time to time if you shall judge it expedient so to do.
