ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 15TH MAY, 1925.)

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1925 (No. 26).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

Contraction of certain Infected Area.

1. The Foot-and-Mouth Disease (Infected Areas) Order of 1925 (No. 24) shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Infected Area described in the Schedule to that Order

Commencement.

2. This Order shall come into operation on the twentieth day of May, 1925.

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1925 (No. 26), and shall be read with the Order referred to in Article 1.
