DANGEROUS DRUGS ACTS, 1920 TO 1925.

SUSPENSION OF WITHDRAWAL OF  
AUTHORISATIONS.

(JOHN JAMES BURNBY.)

Whereas in pursuance of the power conferred upon the Secretary of State by No. 6 of the Raw Opium Regulations, 1921, and by No. 10 of the Dangerous Drugs Regulations, 1921, the authorisations granted by the Raw Opium Regulations, 1921, and the Dangerous Drugs Regulations, 1921, to persons who lawfully keep open shop for the retailing of poisons in accordance with the provisions of the Pharmacy Act, 1868, as amended by the Poisons and Pharmacy Act, 1908, to be in possession of and supply Raw Opium and to carry on the business of manufacturing, selling or distributing the drugs to which Part III of the Dangerous Drugs Act, 1920, applies, were, by Notice dated 19th October, 1923, and published in the London Gazette on the 19th October, 1923, withdrawn from John James Burnby, of 98, Lisson Grove, Marylebone, N.W., who had been convicted of an offence against the Dangerous Drugs Act, 1920;
