Chapelry) of Saint John, Blackpool, in the said County and Diocese, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such New Parishes:

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said New Parish of Christ Church, Blackpool, and of the said New Parish of Saint John, Blackpool, should be formed into a Consolidated Chapelry for all Ecclesiastical purposes, and that the same should be assigned to the said Church of Saint Mark, Blackpool, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Percy Mark, Bishop of Blackburn, as such Bishop, with the consents of the Reverend Henry Ward, Vicar of the Parish of Bispham, in the said County and Diocese, of John Gill, of 'Mayfield,' Hornby Road, Blackpool, Esquire, of Charlotte Emma Wainwright, of The Knowle, Crowborough, in the County of Sussex, Spinster, of Harriet Elizabeth Wright, of Castle Park, Frodsham, in the County of Chester, Spinster, and of Thomas Masheter, of Plumpton Wall, Penrith, in the County of Cumberland, Esquire, as the Patrons of the Vicarage of the said New Parish of Christ Church, Blackpool, and with the consents of Major Charles Hesketh Fleetwood-Hesketh, of Meols Hall, Southport, in the said County of Lancaster, of the said Henry Ward, of The Raikes Hall Estates Company, Limited, Black-pool, of The Clifton Arms and Pier Hotel Company, Limited, Blackpool, and of the County and Lane Ends Hotel Limited, Blackpool, as the Patrons of the Vicarage of the said New Parish of Saint John, Blackpool (in testimony whereof they the said consenting parties have respectively executed this Representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said New Parish of Christ Church, Blackpool, and of the said New Parish of Saint John, Blackpool, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one Consolidated Chapelry for the said Church of Saint Mark, Blackpool, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Mark, Blackpool.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal Wisdom shall seem meet."

"THE SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Mark, Blackpool, comprising:—

"All those contiguous portions of the New Parish (sometime District Chapelry) of Christ Church, Blackpool, and of the New Parish (sometime District Chapelry) of Saint John, Blackpool, both in the County of Lancaster and in the Diocese of Blackburn, which, taken

together, are bounded upon the north west by the New Parish of Saint Paul, Blackpool, upon the north and upon the north east by the Parish of Poulton in the Fylde, both in the said County and Diocese, and upon the remaining sides, that is to say, upon the south east and upon the west, by an imaginary line commencing upon the boundary which divides the said Parish of Poulton in the Fylde from the said New Parish of Christ Church, Blackpool, at the centre of David's Slack Bridge which carries the road leading from Hardhorn to Blackpool across the stream known as the Main Dyke, and extending thence south westward along the middle of such road, which here is called Newton Drive (thereby crossing the boundary which divides the said New Parish of Christ Church, Blackpool, from the said New Parish of Saint John, Blackpool), for a distance of 61½ chains or thereabouts to its junction with Layton Road upon the boundary which divides the said New Parish of Saint John, Blackpool, from the District of Saint Thomas, Blackpool, in the said County and Diocese, and extending thence first northward and then in various directions along the last mentioned boundary (thereby following in part the middle of Layton Road and in part the middle of Talbot Road) for a distance of 60 chains or thereabouts to the junction of Talbot Road with the road called Foxdale Avenue, and extending thence north westward along the middle of Foxdale Avenue for a distance of 15 chains or thereabouts to its junction with Devonshire Road, and extending thence north westward along the middle of Devonshire Road for a distance of $5\frac{1}{2}$ chains or thereabouts to a point near the northern side of the bridge which carries such road across the Poulton and Blackpool Branch Line of the London, Midland and Scottish Railway, upon the boundary which divides the said New Parish of Christ Church, Blackpool, from the said New Parish of Saint Paul, Blackpool.

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Blackburn.
