I, WILLIAM THOMAS FRANCIS HORWOOD, Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for Hackney Carriages at the following place, and do make the following Regulations with regard to the Boundaries for the same, viz.:-

19th September, 1928:-

AT UPPER WOBURN PLACE, W.C.

Six Hackney Carriages:

On the West side of roadway, commencing at a point twenty-eight feet South of the electric lamp standard and immediately opposite No. 11, and extending Southward, by kerb, as far as necessary for six carriages.

Front of vehicles toward the North.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.
