

(c) To incorporate with the Order (with or without modifications or exceptions) all or any of the provisions of the Schedule to the Electric Lighting (Clauses) Act, 1899, and the Acts and portions of Acts incorporated therewith to confer upon the Company all or any powers of the Electricity Supply Acts, 1882 to 1928, and to confer on the Company all such powers as may be necessary for effecting the objects of the undertaking, and to alter, vary or extinguish all rights and privileges which would, or might interfere with any such objects.

(d) To provide that Sections 83 and 84 of the Schedule to the Electric Lighting (Clauses) Act, 1899, shall not apply to the Company or to the Undertaking under the Order.
