FOOT-AND-MOUTH DISEASE (BIRMING-HAM PIG MARKET) (AMENDMENT) ORDER OF 1931.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Removal of Swine from Market.

- 1. Article 3 (Removal of Swine from Market) of the Foot-and-Mouth Disease (Birmingham Pig Market) Order of 1931 is hereby revoked, and the following Article is hereby substituted therefor:—
 - "3. Swine moved to the market to which this Order applies with a licence granted under this Order shall not be moved therefrom except with a licence of an Inspector of the Local Authority of the City of Birmingham, or to any place other than a slaughterhouse or bacon factory approved by the Inspector and situate in the area to
