The Civil Service Commissioners hereby give notice that an Open Competitive Examination will be held in London, the written work commencing on the 4th July, 1933, under the Regulations respecting Open Competitive Examinations for the situations of Assistant Inspector of Taxes in the Inland Revenue Department and Third Class Officer in the Ministry of Labour, dated the 15th January, 1932, and published in the London Gazette of the same date.

Not fewer than 30 vacancies for Assistant Inspectors of Taxes and 10 vacancies for Third Class Officers will be filled on the result of this Examination, if so many candidates should be found to be qualified in all respects.

of at least forty days from this date, in pursuance of the powers conferred upon him by Section 7 of the aforesaid London Traffic Act, to make Regulations amending the London Traffic (Restricted Streets) Regulations.

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Route No. 65) Provisional Regulations, 1933, to come into operation forthwith as Provisional Regulations to continue in force until Regulations have been made in accordance with the provisions of Section 1 of that Act.

These Regulations provide for the operation of certain additional early morning omnibus journeys on route No. 65 (Ealing, Argyle Road, and Leatherhead) between Ealing, Argyle Road, and Kew Bridge.
