The KING's Most Excellent Majesty in Council.

WHEREAS His Majesty by Order in Council made the 20th December, 1927, ordered that Roderick Sinclair Meiklejohn, Esquire, C.B. (now Sir Roderick Sinclair Meiklejohn, K.B.E., C.B.) and David Beveridge Mair, Esquire, and Lawrence Cary Hampton Weekes, Esquire, should be His Majesty's Civil Service Commissioners for the purposes of and with the powers mentioned in an Order in Council made the 5th February, 1918, and two Orders in Council both made the 22nd July, 1920 (being Orders

making provision with respect to the appointment, tenure of office, powers and duties of His Majesty's Civil Service Commissioners) to hold their offices during the pleasure of His Majesty, the said Sir Roderick Sinclair Meiklejohn being First Commissioner, and the said David Beveridge Mair, Esquire, and Lawrence Cary Hampton Weekes, Esquire, being Assistant Commissioners, holding also the offices, respectively, of Director of Examinations and Secretary to the Civil Service Commission:

And whereas the said David Beveridge Mair, Esquire, and Lawrence Cary Hampton Weekes, Esquire, will retire from their offices as aforesaid, on the 24th March, 1933:

Now, therefore, His Majesty, by and with the advice of His Privy Council, doth order, and it is hereby ordered, that as from the 25th day of March, 1933, the said Sir Roderick Sinclair Meiklejohn, K.B.E., C.B., and George Gillies Mennell, Esquire, and Leonard Blaikie, Esquire, shall, subject to the provisions of the said Orders in Council made the 5th February, 1918, and the 22nd July, 1920, be His Majesty's Civil Service Commissioners for the purposes of and with the powers mentioned in the said Orders, the said Sir Roderick Sinclair Meiklejohn being First Commissioner, and the said George Gillies Mennell, Esquire, and Leonard Blaikie, Esquire, being Assistant Commissioners, holding also the offices, respectively, of Secretary to the Civil Service Commission, and Director of Examinations.
