

HEREBY GIVE NOTICE that they PROPOSE TO FIX GENERAL MINIMUM PIECE RATES and GUARANTEED TIME RATES and to VARY THE OVERTIME RATES for female piece workers on Hessian Weaving employed in any part of Great Britain other than Aberdeen, Barrow-in-Furness, Dundee, Dysart, Kirkcaldy and Tayport.

Particulars of the minimum rates proposed to be fixed and of the proposed variation may be obtained on application to the Secretary of the Trade Board.

This Notice is issued with the consent of the Minister of Labour.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any Objections to the above Proposal to Fix and to Vary which may be lodged with them within two months from the 30th May, 1933. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary, Jute Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W.1. It is desirable that Objections should state precisely and, so far as possible, with reasons, what is objected to.
