

vacancy, the appointment of a Provost shall for that turn lapse to the Lord Chancellor."

And whereas by Statute II, 4, it was enacted as follows:—

"4. The Provost shall reside in the College seven calendar months at least in each year, whereof eighteen weeks at least shall be in the usual College terms. But in case of the Provost's sickness, or for any other urgent cause, the Lord Chancellor may dispense with the Provost's residence for such a period as may seem to the Lord Chancellor to be required by the necessities of the case."

We, the said Provost and Fellows of the said College do hereby in exercise of the powers given to us by the Seventh Section of the said Act alter Statute II, 2, by substituting for the word "Dean" the word "Vice-Provost"; and Statute II, 4, by substituting for the existing clause the following clause:—

"4. The Provost shall reside in the College in each academical year, that is to say in each period of twelve months beginning on the first day of October, for not less than twenty-eight weeks, of which eighteen weeks at least shall be in the usual College terms. But in case of the Provost's sickness, or for any other reasonable cause, the Lord Chancellor may dispense with the Provost's residence for such a period as may seem to the Lord Chancellor to be required by the circumstances of the case."
