SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT, 1940.

Whereas the Mayor, Aldermen and Burgesses of the Borough of Blackburn (hereinafter called the Corporation) have made application to the Minister of Health for the issue of an Order under the Special Enactments (Extension of Time) Act, 1940, so as:—

Whereas the Mayor, Aldermen and Burgesses of the Borough of Barnsley have made application to the Minister of Health for the issue of an Order under the Special Enactments (Extension of Time) Act, 1940, to extend the period limited by the following Orders, for the compulsory purchase of the lands specified in the schedules thereto:—
