BANKRUPTCY, ENGLAND, GENERAL RULES.

Notice is hereby given in accordance with section 1 (1) of the Rules Publication Act, 1893, that after the expiration of at least 40 days from the date hereof the Lord Chancellor, with the concurrence of the President of the Board of Trade, proposes to make Rules suspending the requirement in the Bankruptcy Rules, 1915 (App., Pt. II, Reg. 6), that bills of costs are to be written on one side of the paper only.
