The Lords Commissioners of His Majesty's Treasury give notice that:—

(A) Subscriptions for 3 per cent. Savings Bonds 1955-1965 under the prospectuses dated the 27th December, 1940, issued by the Bank of England, the Postmaster General and the National Debt Commissioners respectively, will not be received after the 30th April, 1942.

(B) Subscriptions for 2½ per cent. National War Bonds 1949-1951 under the prospectuses dated 8th October, 1941, issued by the Bank of England, the Postmaster General and the National Debt Commissioners respectively, will continue to be received until further notice, provided that—

1. In respect of subscriptions the interest on which accrues from a date later than the 30th

April, 1942 (save for subscriptions lodged before the 1st May, 1942, in accordance with the special arrangements available to holders of securities transferred to the Treasury under the Acquisition of Securities (No. 2) Order, 1942, and the Acquisition of Securities (Isle of Man) (No. 2) Order, 1942, dated the 26th January, 1942, or under earlier Orders) the commission payable to Bankers and Stockbrokers on subscriptions bearing their stamp will be reduced to 1d. per 1100 nominal subscription; and 2. On an after the 1st May, 1942, subscriptions will be accepted by the Bank of England in multiples of 50 with a minimum of 50. On the Post Office and Trustee Savings Bank Registers, subscriptions must be for amounts of 50 multiples thereof, subject to a minimum of 150 fro for the first subscription.
