Owing to the newsprint position, the list of Honours to be announced on the occasion of the King's Birthday will be communicated to the Press for publication in two parts, the first on the morning of Wednesday, 2nd June, and the second on the morning of Friday, 4th June. The second part will be restricted to civil awards on the United Kingdom list as follows: appointments to the Fourth and Fifth Classes of the Most Excellent Order of the British Empire, and to the Companionship of the Imperial Service Order, together with awards of the British Empire Medal and Commendations for valuable service in the air.

## TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 4th June, 1943, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1943, to the amount of £90,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 7th June, 1943, to Saturday, the 12th June, 1943, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

Notices of Dissolution of Partnership will not be inserted unless signed by the Partners named therein, or by their legal representatives; and the signature or representative character of the signatory must be verified by Statutory Declaration made by a Solicitor of the Supreme Court.

A Notice of Dissolution of Partnership not signed by all the Partners, or their legal representatives, must be accompanied by a Statutory Declaration made by a Solicitor of the Supreme Court to the effect that such notice is given in pursuance of the terms of the partnership to which it relates.

Advertisements purporting to be issued in pursuance of Statutes or under Orders of Court will not be inserted unless signed or attested by a Solicitor of the Supreme Court.

Advertisements relating to Bills before Parliament will not be inserted unless signed by a Parliamentary Agent or a Solicitor of the Supreme Court.

Table or tabular matter will be charged at the rate of £1 10s. per quarter page or part thereof.

(g) In Notices of Dissolution of Partnership, the signatures of the partners will not be charged for.
