PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 6th day of September, 1944 (P.M. 2248/44), in the words following, viz.:—

following, viz.:—
"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine, therein, or to the widow or relative of a deceased Officer, Seaman or Marine, shall be paid in such manner, and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

by Order in Council:
"And whereas by the Pensions (Increase) Act, 1944, provision is made under a general scheme, subject to certain conditions and restrictions, for the increase of certain civil pensions payable in respect of public service, and for the increase under special scheme of certain pensions payable under

a special scheme of certain pensions payable under the Superannuation Acts, 1834 to 1943: "And whereas we are of opinion that provision should be made for the increase of certain Naval pensions and other awards to correspond, as nearly as may be, with the benefits provided by the Pensions (Increase) Act, 1944:

Pensions (Increase) Act, 1944:

"And whereas by Clause 7 of the said Act it is enacted, inter alia, that in determining whether any person is eligible for a special Greenwich Hospital pension, under section five of the Greenwich Hospital Act, 1869, and the amount of any such pension, any additional sum payable under any Order in Council for the grant to persons who have been in His Majesty's Naval Service of benefits corresponding to those provided under the Act shall be disregarded:

corresponding to those provided under the Act shall be disregarded:
"We beg humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to empower us to grant at our discretion increases of retired pay or pension to the extent and under the conditions prescribed in the Schedules

annexed hereto.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

"SCHEDULE I.

"This Schedule relates to:

(a) officers' service retired pay, or the service

portion of disability retired pay,
(b) the service retired pay, or the service portion
of disability retired pay, of members of Queen
Alexandra's Royal Naval Nursing Service, and
Nursing Service Reserve,

(c) men's Service pensions, including elements rank and age,

(d) the Service pensions of Teachers in the Girls' and Infants' Schools of the Royal Marine Forces who are pensionable under Order in Council of the 10th February, 1905, and previous Orders.

(e) pensions payable under Order in Council of the 10th Council of the 10t

the 27th October, 1936, and previous Orders relating to Riggers and Yardcraft personnel,

(f) pensions payable under Order in Council of the 3rd July, 1939, and previous Orders relating to European members of the Hong Kong Dockyard Police,

(g) pensions payable under Order in Council of

relating to certain Shipwrights,

(h) Officers' widows' "ordinary" pensions and
children's "ordinary" compassionate allowances,

each bar) and pensionary awards attaching to

(k) Retired Officers Naval Pensions and Good

(i) any award increased under Orders in Council of the 13th August, 1920, or the 8th December, 1924, or which would have been increasable under those Orders but for the income limits imposed thereby.

2. Conditions of Eligibility.

"An award to which this Schedule relates may be increased provided the following conditions are

fulfilled.

(a) The total income of the pensioner, including pension and pension increase, does not exceed, in the case of a pensioner who is married, or has at least one dependant, £300 a year, or in any other case, £225 a year, but in assessing income for this purpose the first £52 a year of income other than the increasable pension or pensions shall be disregarded.

(b) (i) The pensioner has attained the age of 60 years (or, where the pension is one payable on account of widowhood, 40 years), or has not attained the age of 16 years, or

(ii) the pensioner was invalided from the Naval

Service, or

(iii) the pensioner is a woman who has at least

one dependant, or (iv) the pensioner is permanently incapacitated by physical or mental infirmity from engaging in any regular full-time employment.

"3. Amount of Increase.

"The maximum increase admissible is follows:

(a) If the pensioner is married, or has at least one dependant, 30 per cent. of the pension where the pension does not exceed £100 a year, or 25 per

cent. of the pension where the pension exceeds floo a year but does not exceed floo a year, or 20 per cent. of the pension where the pension exceeds floo a year,

(b) in other cases, 30 per cent. of the pension

where the pension does not exceed £75 a year, or 25 per cent. of the pension where the pension exceeds £75 a year but does not exceed £150 a year, or 20 per cent. of the pension where the pension

exceeds £150 a year; but no pension shall be increased by an amount greater than is sufficient to bring the total income of the pensioner up to the appropriate income limit in paragraph 2 (a) above.

"4. Provisions regarding the calculation of the increase.

increase.

(a) Any portion of a pension which has been commuted shall not be regarded as part of the pension for the purposes of this Schedule, except that where the commutation was effected after 31st December, 1943, the commuted portion may wholly or partially be so regarded.

(b) The income of a married pensioner shall be deemed to include the income of the husband or wife of the pensioner, but the income of a pensioner shall not be otherwise deemed to include the income of any other person.

(c) A pensioner shall be regarded as unmarried unless the husband or wife of the pensioner is alive, but where a husband and wife are living apart, they may be treated as unmarried persons.

(d) To be regarded as dependent on the pensioner for the purpose of this schedule a person must be in fact wholly or mainly supported by the pensioner, must not have an income from other sources (apart from income from any scholarship or educational endowment) in excess of £52 a year, and must be either

(i) the parent, brother, sister, child, uncle or

scholarship or educational endowment) in excess of £52 a year, and must be either

(i) the parent, brother, sister, child, uncle or aunt of the pensioner, or of the pensioner's husband or wife, or deceased husband or wife or the child of any such relative ("child" including legitimate and illegitimate children, step-children, and statutorily adopted children), or the pensioner's step-father or step-mother, or

(ii) under 16 years of age, or receiving full-time instruction at an educational establishment, or undergoing full-time training for a trade.

or undergoing full-time training for a trade,

profession, or vocation.

(e) Where in addition to the increasable pension, a pensioner is in receipt of other pension or

sion, a pensioner is in receipt of other pension or pensions of the following types:—

(i) a pension to which this Schedule applies;
(ii) a pension arising from service in the Forces (but excluding any pension or any part of a pension granted in respect of disablement or death attributable to, or aggravated by such service);

service);

(iii) a pension coming within the first Schedule to the Pensions (Increase) Act, 1944 (but excluding any portion of such pension representing an addition consequent on the receipt of war bonus during the present war), all such pensions shall be aggregated for the purpose of determining the percentage, increase permissible on the pension or pensions to which this Schedule applies.

(f) Where a husband and wife are both receipt of pensions to which this Schedule applies, both pensions may be increased individually, but so that the appropriate joint income limit is not exceeded, and where the increase admissible thus falls to be restricted, the increase shall be apportionally the province of the provin

talls to be restricted, the increase shall be apportioned proportionately between the pensions.

(g) Where a widow in receipt of a pension on account of widowhood has dependent on her a child or children under 16 years of age receiving pension or compassionate allowance in respect of her husband's services, the widow's pension and children's awards shall be aggregated for the purpose of determining the percentage increase applicable to them. applicable to them.

"SCHEDULE II. -;

"1. This Schedule relates to Officers' service retired pay, or the service portion of disability retired pay, awarded or assessed under the provisions of Orders in Council of the 22nd January, 1920, and 17th October, 1923, 4th May, 1935, and in subsequent Orders in Council, authorising scales of service retired pay or service portions of disability retired pay based upon the consolidated rates of retired pay authorised by Order in Council of the 4th May, 1935; but shall not apply to retired pay granted to certain Officers retired under the Special Retirement Schemes sanctioned by Orders in Council of the 14th July, 1922, and 16th January, 1924, whose retired pay was specifically exempted from subsequent periodical review.

"It also relates to pensions payable under Order

"It also relates to pensions payable under Order in Council of the 27th October, 1936, and previous Orders relating to Riggers and Yardcraft personnel and to pensions payable under Order in Council of the 27th October, 1936, and previous Orders relating

to certain Shipwrights, except that it does not relate to any such pensions payable by reason of death or retirement before the 21st February, 1922, nor Retired Pay awarded or assessed at men's pension rates.

" 2. Such awards may be increased as follows: (i) If the award does not exceed £400 a year, by

(i) If the award exceeds £400 a year, but does not exceed £600 a year, by 7½ per cent.;
(iii) If the award exceeds £600 a year, but does not exceed £645 a year, to the latter figure.

not exceed £645 a year, to the latter figure.

"This increase shall be given without regard to the income or other circumstances of the pensioner, but where an increase of the award is admissible under the provisions of the First Schedule, the amount of the latter increase shall be limited to the excess, if any, over the increase authorised by this paragraph.

"3. Incomputing the increases permissible under paragraph 2, any sum commuted from the original retired pay shall be added to the existing rate, and eligibility for increase shall be determined by, and the rate of increase assessed on, the total so obtained.

"SCHEDULE III.

" Special Provisions.

"I. Additional retired pay granted to retired Officers in respect of service in certain salaried appointments made under the provisions of Orders in Council of the 13th December, 1921, 26th May, 1925, and 23rd July, 1931, and subsequent amending Orders in Council, may be increased to the extent to which a corresponding award under the Superanuation Acts, 1834 to 1943, could be increased under the provision of the Pensions (Increase) Act, 1944.

"2. The retired pay of an Officer who, under regulations in force prior to Order in Council of the regulations in force prior to Order in Council of the 22nd January, 1920, was granted a higher rate of retired pay than that for which he would have been eligible under the provisions of that Order, shall not be increased under the provisions of Schedule II to an amount greater than that for which he would have been eligible had he been granted the appropriate rate under the provisions of the said Order in Council.

"3. The income limits imposed by Orders in Council of the 27th March, 1923, and the 1st February, 1926, in connection with the re-assessment of certain awards shall be withdrawn and the income limits set out in paragraph 2 of the First Schedule above shall be substituted.

"General Provisions.

"I. Where the amount to which a pension may be increased is less than the amount to which the pension might have been increased had it been smaller, the pension may be increased to the latter amount.

amount.

"2. In calculating, for the purposes of Orders in Council of the 13th August, 1920, or the 8th December, 1924, the means of any pensioner or the amount of any pension, any increase for which provision is made by this Order in Council shall be disregarded, and where the amount of any pension has been increased under the aforesaid Orders of the 13th August 1920, or the 8th December 1921. or by any other corresponding enactment, the increase for which provision is made by this Order in Council shall be calculated upon the amount of the pension as so increased.

3. Where a pension has been increased by virtue of any addition since the 3rd September, 1939, to the emoluments of any office or employment in respect of which, or on retirement from which, the pension is payable, and the said addition was an addition by way of war bonus or other similar allowance, the increase authorised under the First and Second Schedules shall be calculated as if the pension had not been increased by reason of the said addition and addition, and

(a) if the amount of the increase authorised under these Schedules, when so calculated as aforesaid, is equal to less than the amount by which the pension has been increased by reason of the said addition, the pension shall not be increased under these Schedules; and,
(b) in any other case, the amount of the increase authorised by these Schedules, after being so calculated as aforesaid, shall be reduced by the amount by which the pension has been increased by reason of the said addition.

"4. Where part of a pension has been surrendered

4. Where part of a pension has been surrendered by a pensioner for the purpose of enabling a grant to be made of a pension to the wife or husband of the pensioner under any arrangement whereby a pension is payable to the wife or husband of the pensioner during the pensioner's lifetime, then for the purpose of determining the percentage by reference to which the authorised increase of each of these pensions is to be calculated under the First and Second Schedules, each of the pensions shall be and Second Schedules, each of the pensions shall be deemed to be of an amount equal to the aggregate

deemed to be of an amount equal to the aggregate of the two pensions.

"5. An increase in an award under the provisions of this Order in Council shall not be taken into account in determining the amount of, or the eligibility for, a Greenwich Hospital Special pension under Section 5 of the Greenwich Hospital Act, 1869, as amended by Section 4 of the Greenwich Hospital Act, 1898.

"6. The Admiralty may prescribe the manner in which the means of a pensioner are to be calculated for the purpose of this Order in Council, and may require from time to time of all pensioners who claim, or may be in receipt of, an increase of pension under the First Schedule a declaration in such form as may be prescribed regarding their means of form as may be prescribed regarding their means of livelihood and condition as regards dependants.

"7. An increase of pension granted under the First Schedule may be reviewed with a view to increase, reduction or cessation, whenever a change in the circumstances and means of livelihood of the

pensioner renders such review necessary.

"8. Any general conditions attaching to the grant or continuance of retired pay or pension under Naval Regulations shall also apply to the grant or con-tinuance of any increase to such retired pay or pension awarded under the provisions of this Order

in Council.

"9. The provisions of this Order in Council shall have effect from the 1st January, 1944, and shall continue in force until the 31st December, 1945, inclusive."

WHEREAS by section 21 (1) (a) of the Foreign Marriage Act, 1892 (55 & 56 Vict. c. 23), His Majesty The King in Council is authorised to make regulations prohibiting or restricting the exercise by marriage officers of their powers under the said Act in places where sufficient facilities appear to His Majesty to exist without the exercise of those powers for the solemnization of marriages to which a British subject is a party:

And whereas by section 21 (2) of the said Act it is provided that regulations made in pursuance of the said section may be made inter alia with reference to any particular class of case:

And whereas it appears that without the exercise of their powers under the said Act by marriage officers in Egypt, Iran and Iraq sufficient facilities exist under the forms of marriage referred to in section 22 of the said Act for marriages in Iran and Iraq of British subjects who are serving in Iran or Iraq in any of the Services set out in the Schedule to this Order:

And whereas the provisions of the Rules Publication Act, 1893 (56 & 57 Vict. c. 66), have been complied with in respect of the regulation hereinafter

Now, therefore, His Majesty by virtue and in exercise of the powers conferred by the Foreign Marriage Act, 1892, or otherwise enabling Him in this behalf is pleased by and with the advice of His Privy Council to order, and it is hereby ordered as follows:-

1. This Order may be cited as the Foreign Marriagen (Egypt, Iran and Iraq) Order in Council

1944.

2. No marriage officer in Egypt or Iran or Iraq shall without special permission of the Secretary of State solemnize any marriage between parties either of whom is serving in Egypt or Iran or Iraq in any of the Services set out in the Schedule to this Order.

3. Nothing in this Order shall be deemed to affect

the powers as a marriage officer under section 12 of the Foreign Marriage Act, 1892, of any commanding officer of any of His Majesty's Ships.

4. The Foreign Marriages (Egypt) Order in Council, 1928 (S.R. & O. 1046), and Foreign Marriages (Iran) Order in Council, 1942 (S.R. & O. 1448), are hereby repealed.

WHEREAS by section 3 of the Naval and Marine Pay and Pensions Act, 1865, 28 & 29 Vict. c. 73, it is enacted that all pay, wages, pensions, bounty money, grants or other allowances in the nature thereof payable in respect of services in His Majesty's payal or marine force to a person being or basing thereof payable in respect of services in His Majesty's naval or marine force to a person being or having been an officer, seaman or marine, or to the widow or any relative of a deceased officer, seaman or marine, shall be paid in such manner, and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

And whereas His Majesty deems it expedient to make further provision concerning retired pay, pensions and other grants in cases where the disablement or death, of members of the naval forces is due to service during the present war:

Now, therefore, His Majesty, in exercise of the powers conferred upon Him as aforesaid and of all other powers whatsoever Him thereunto enabling, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

The Order in Council dated 20th January, 1944, S.R. & O. 1944 No. 99, relating to members of the naval forces as therein defined, shall be amended in the respects set out in the following Articles, which shall be construed as one with the said Order in Council in Council.

1. Article 1 (2) shall have effect as if subparagraph (a) included a legitimate child of parents married after the material date where the child would have

come within subparagraph (c) or (d) but for the

2. Where a member of the naval forces has sustained a minor injury specified in Table 1 of the Third Schedule as well as some other disablement due to war service, the degree of which is less than 100 per cent., and a composite assessment of the degree of the disablement from both causes is no higher than the assessment for the other disablement alone Article o shall have effect so as to authorise higher than the assessment for the other disablement alone, Article 9 shall have effect so as to authorise an award under Article 11 in respect of the minor injury as well as an award under Article, 10 or 11 in respect of the other disablement.

3. In the Table in Article 12 (2) for the figures £24 and 6s. wherever they occur there shall be substituted the figures £30 and 7s. 6d. respectively.

4. In Article 12 (5) subparagraph (c) shall be deleted and for subparagraph (b) there shall be substituted the following subparagraph:

"(b) he is incapable of self-support and in need."

5. In Articles 13 and 35 for the reference in

5. In Articles 13 and 35 for the reference in paragraph (1) to the age of 8 years there shall be substituted a reference to the age of 5 years, and in paragraph (2) for the figure £50 there shall be substituted the figure £80.

6. In Article 18, the following paragraph shall be inserted after paragraph (1), paragraphs (2), (3) and (4) being renumbered (3), (4) and (5) respectively:—

Where it is certified that a member of the "(2) Where it is certified that a member of the naval forces (not being an officer) who has an eligible dependant should, on completion of a course of approved institutional treatment, abstain from work for a prolonged period in consequence of the condition which necessitated that treatment, he may be treated as if he were eligible throughout that period for a treatment allowance under Article 17 his personal allowance under

ment, he may be treated as if he were eligible throughout that period for a treatment allowance under Article 17, his personal allowance under that Article being increased by such an amount as will bring the aggregate weekly amount of that allowance, the additional allowance under that Article in respect of his first eligible dependant and any National Health Insurance benefit for which he is eligible, up to 59s. a week."

In Article 19 for the words "not exceeding 20s. a week where the member is an officer or 16s. a week in any other case" there shall be substituted the words "not exceeding 21s. in respect of any one day (subject to a maximum payment of 30s. in respect of any one week)", and at the end there shall be inserted the words "Provided that the rate of a treatment allowance awarded to a member under this Article in respect of any period of a week or less shall not exceed the amount by which the weekly value of the member's existing award under Part III or Part VI (excluding any award under Article 13, 14, 15 (1) (a) or 15 (1) (d)) falls short of the weekly value of the award which would have been appropriate in the case of that member under Article 17 (2) if he had been eligible for an award under that Article."

8. In Article 24 (1) there shall be inserted at the end the following words:—

"Provided that, where the widow of a Lieutenant-Commander, Lieutenant, Sub-Lieutenant, Acting Sub-Lieutenant, Commissioned Officer from Warrant Rank or Warrant Officer or an officer of equivalent rank in the Royal Marines—

9. Article 24 (2) (a) and Table 2 in the Fourth Schedule shall, have effect as if, in the column of that Table showing the higher rates of pension, for the rates 33s. 6d., 31s. 3d. 29s. and 26s. 8d., there were substituted the rates 36s., 35s., 34s. and 32s. 6d. respectively.

10. In Article 24 (2) (a) (ii) after the number "31" there shall be inserted the number "32" and after the number "36" there shall be inserted the words: "or of an allowance out of public funds analogous to an allowance under Article 32."

11. In Article 28 (5) (a) for the figure 22s. 6d. there shall be substituted the figure 27s. 6d.

12. Proviso (a) to Article 28 (6) shall apply to an unmarried dependant living as a wife of a Lieutenant-Commander, Lieutenant, Sub-Lieutenant, Acting Sub-Lieutenant, Commissioned Officer from Warrant Rank or Warrant Officer or an officer of equivalent rank in the Royal Marines.

13. In Article 31, paragraph (2) and the proviso thereto shall be deleted and the following paragraph

16. In Article 42 after the word "award" in paragraph (a), there shall be inserted the words "other than an award at the half-pay rate."

17. In Article 44 (5) (d) for the words "all causes thereof and the degree of disablement which is due to the Great War service or the earlier service" there shall be substituted the words "all causes of the disablement which is due to war service or to his previous service, and the degree of disablement on which the existing award is based."

18. In Article 54 the existing proviso shall be numbered (a) and at the end thereof there shall be inserted the following words "and (b) except for the purposes of an award under Article 14, the reference in this Article to retired pay awarded under this Part shall be treated as excluding retired pay awarded under this Part at the half-pay rate."

19. Each of the foregoing Articles shall be deemed to have come into operation on the commencing date specified in the following Table in relation to that Article, so, however, that no payment shall be made by virtue of any of the said Articles in respect of any period before the commencing date so specified in relation to that Article.
