ROYAL WARRANT FOR THE BURMA GALLANTRY MEDAL.

GEORGE THE SIXTH, by the Grace of God, of Great Britain, Ireland, and the British Dominions beyond the seas, King, Defender of the Faith, Emperor of India.

To all to whom these Presents may come:

GREETING:

Whereas We have taken into Our consideration the means of adequately rewarding acts of gallantry by members of certain of our Armed Forces in Burma:

Now, We do by these Presents for Us, Our Heirs and Successors, institute a new Decoration and We are pleased to make the following ordinances for its governance.

First.—It is ordained that the Decoration shall be named "The Burma Gallantry Medal "

Secondly.—It is ordained that the Medal may be conferred by Our Governor of Burma upon Governor's Commissioned Officers, Non-Commissioned Officers and other ranks of the

Burma Army, the Burma Frontier Force, the Burma Military Police, the Burma Royal Naval Volunteer Reserve Force and the Burma Auxiliary Air Force, for any act of conspicuous gallantry performed in connection with their duties.

Thirdly.—It is ordained that the Decoration shall be a Silver Medal of the same size as a War Medal having therein the Effigy of the Sovereign. On the reverse side a laurel wreath with the words "Burma", "For Gallantry" in relief thereon. The medal shall be worn on the left breast immediately on the right of all War Medals suspended by a dark green ribbon 13 inches wide with a crimson

bar in the centre 1 of an inch wide.

Fourthly.—It is ordained that any act of gallantry which is worthy of recognition by the Award of the Burma Gallantry Medal but is performed by one upon whom the decoration has already been conferred, may, at the discretion of Our Governor of Burma be recorded by a bar attached to the riband by which the medal is suspended. For every such additional act an additional Bar may be added and for each such bar awarded a small silver rose shall be added to the riband when worn alone.

Fifthly.—It is ordained that Our Governor of Burma may cancel and annul the award of the Medal to any person and that thereupon the said person shall be required to surrender his Insignia, provided that Our Governor may subsequently abrogate any such cancellation and annulment.

Sixthly.—It is ordained that it shall be competent for Our Governor of Burma for the time being to make Regulations to carry out the purposes of this Warrant.

To all to whom these Presents may come:

Whereas We have taken into Our consideration the means of adequately rewarding the long, faithful and honourable service of members of certain of Our Armed Forces in Burma:

Now, We do by these Presents, for Us, Our Heirs and Successors, institute a new Decoration and We are pleased to make the following ordinances for its governance.

First.—It is ordained that the Decoration shall be named "The Order of Burma".

Secondly.—It is ordained that appointments to the Order may be made by Our Governor of Burma from among Governor's Commissioned Officers of the Burma Army, the Burma Frontier Force or the Burma Military Police, for long, faithful and honourable service.

Thirdly.—It is ordained that the Insignia of the Order shall be a Badge one and a half inches in diameter composed of rays of gold

issuing from a gold medallion in the centre charged with a peacock in his pride azure within a circle of the last inscribed with the words "Order of Burma" also in gold; the whole ensigned with the Imperial Crown proper. The Badge to be suspended from a riband of dark green one and a half inches wide edged with light blue one quarter of an inch wide worn round the neck.

Fourthly.—It is ordained that Governor of Burma may cancel and annul the appointment to the Order of any member and that thereupon the said member shall be required to surrender his Insignia, provided that Our Governor may subsequently abrogate any such cancellation and annulment.

Fifthly.—It is ordained that members of the Order of Burma may use the letters "O.B."

after their names.

Sixthly.—It is ordained that it shall be competent for Our Governor of Burma for the time being to make Regulations to carry out the purposes of this Warrant.

One of the Directions also prohibits, without per-One of the Directions also prohibits, without permission under the Order, the carrying out within the area shown coloured blue and being within the inner edge of the dark blue boundary defined upon Map No. I of alterations to existing buildings and of operations required for the maintenance of existing buildings except where the cost of such alterations or maintenance does not exceed in a period of 12 months the sum of Two hundred and fifty pounds (\$250) or twenty-five per cent. of the net annual value of the premises, whichever is the greater.
