(Supply of Electricity by the Mayor Aldermen and Burgesses of the Borough of Chesterfield in parts of the urban district of Staveley and the rural districts of Chesterfield and Clown, all in the County of Derby; and matters incidental thereto.)

2. To authorise the Corporation to generate, supply, distribute and sell electrical energy for all public and private purposes as defined by the Electricity (Supply) Acts 1882 to 1936 within the added areas and to confer upon the Corporation all necessary and usual powers in that behalf.

3. To extend and make applicable to the added areas, with or without amendment, the provisions contained in the Chesterfield Corporation Act 1923 and any other Act or Order relating to the electricity undertaking of the Corporation and to apply such provisions to the undertaking to be authorised by the Order subject to such variations and exceptions as may be contained therein.
