### EXPLANATORY NOTE.

These Regulations provide for the manner in which all claims for benefit under the National Insurance Act, 1946 (other than death grant) and the payment of such benefit shall be made. Part II contains provisions relating to the forms on which claims are to be made, the information to be given when claiming, the time within which to claim and the interchance between claims for certain benefits (including change between claims for certain benefits (including benefits under the National Insurance (Industrial Injuries) Act, 1946). Part III contains provisions relating to the method of payment of benefit, for the disqualification for benefit which is claimed out of time and for the extinction of the right to sums payable by way of benefit where payment is not obtained in time. Part IV contains special provisions for certain benefits. Part V makes provision for claims and payments in the case of persons unable to act, and on death, and provides for a penalty for breaches of the regulations. of the regulations.

### EXPLANATORY NOTE.
