##### BRACKNELL NEW TOWN (DESIGNATION) ORDER, 1949.

Notice is hereby given that the Minister of Town and Country Planning in pursuance of the powers vested in him by Section 1 of the New Towns Act, 1946, on the 17th day of June, 1949, made an Order designating as the site of a proposed New Town an area of land comprising approximately 1,850 acres situate in the Rural District of Easthampstead in the administrative County of Berks, which land is shown on the map annexed to the Order.

2. The area thus designated is some 770 acres less in extent than the area which was shown on the map annexed to the draft Bracknell New Town (Designation) Order, 1948, which was deposited for inspection at the offices of the Easthampstead Rural District Council, Church Road, Bracknell, Berks, on or about the 7th December, 1948, and with respect to which a Public Local Inquiry was held at the Victoria Hall, Church Road, Bracknell, Berks, on the

23rd day of February, 1949. This reduction in the size of the area has been effected by the exclusion of 625 acres of land on the west and south west, and 145 acres on the north and north east.

3. In compliance with the provisions of Paragraph 5 of the First Schedule to the Act, a copy of the Order and of the map have been deposited at the Offices of the Easthampstead Rural District Council, Church Road, Bracknell, Berks, and may be inspected without payment of fee on weekdays (except Saturdays) between the hours of 9 a.m. and 1 p.m., and 2 p.m. and 5 p.m., and between 9 a.m. and 12 noon on Saturdays. A copy of the Order and of the map have also been deposited at the Ministry of Town and Country Planning, No. 32, St. James's Square, London, S.W.1, where they may be inspected between the hours of 9.30 a.m. and 5 p.m. on weekdays (except Saturdays) and between 9.30 a.m. and 12 noon on Saturdays.
