The injured man was lying on an upper grating, and Petty Officer Stoker Mechanic WATT, on hearing and seeing the accident, immediately went to his aid, having to pass through the steam blowing at 250 lbs. per square inch to do so. He forced the stoker to jump off the grating with him on to a walk about eight feet below and then pulled him to the forward end of the steam-filled boiler-room, from where he was brought out to safety.

In helping the injured man, Petty Officer Stoker Mechanic WATT was very badly scalded. He had shown complete disregard of his own safety, although he must have been fully aware of the danger to which he unhesitatingly exposed himself

in going to the aid of the rating.
