## EXTENSION TO BRITISH GUIANA AND ST. LUCIA OF THE UNITED KINGDOM DOUBLE INCOME-TAX AGREEMENT WITH CANADA.

In an Exchange of Letters between the United Kingdom Government and the Canadian Government it has been agreed that the operation of the Agreement of the 5th June, 1946, between the Government of the United Kingdom and the Government of Canada for the Avoidance of Double Taxation and the Prevention of Fiscal Evasion with respect to Taxes on Income (S.R. & O. 1946 No. 1885) shall extend to the Colonies of British Guiana and St. Lucia.

For both Colonies the date from which the extension will be effective is the 1st January, 1952, and the tax concerned in each Colony is the Income-tax.

## URBAN DISTRICT OF LEEK.

(2) to provide that section 15 (Cemetery to be enclosed) of the Cemeteries Clauses Act, 1847, which is incorporated with the local Act by section LXIX thereof, shall cease to apply to the Council's cemetery, and to repeal section LXXIV (Height of Cemetery Walls) of the local Act;

(3) to amend further section XLIII (Purchase of Lands by Agreement) of the local Act, as amended by Article 1 of the Leek Order 1887, by increasing from 12 acres to 15 acres the maximum quantity of land which may be held by the Council for the purposes of the cemetery;

(4) to repeal section LXXI (Chapels for consecrated and unconsecrated Part) of the local Act, in order to enable the Council to use the existing chapel in the unconsecrated part of the cemetery as a mortuary and post-mortem room under the powers of section 198 (Provision of mortuaries and post-mortem rooms) of the Public Health Act, 1936; and

(5) for the several purposes of the application, or for purposes connected with, incidental to or consequent on those purposes, to make any such alteration or amendment of the said local Act, or of any other local Act, or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875 and in force in the district as may be necessary or desirable;
