SAFETY CONVENTION.

The Merchant Shipping (Safety Convention Countries) (Various) Order, 1954.

Made - - - 10th February, 1954. Laid before Parliament 11th February, 1954. Coming into Operation upon the date of publication in the London Gazette. 16th February, 1954.

At the Court of Saint James, the 10th day of February, 1954.

Whereas Her Majesty, in pursuance of the Regency Acts, 1937 to 1953, was pleased, by Letters Patent dated the 20th day of November, 1953, to delegate to Her Majesty Queen Elizabeth The Queen Mother, Her Royal Highness The Princess Margaret, His Royal Highness The Duke of Gloucester, Her Royal Highness The Princess Royal and the Earl of Harewood, or any two or more of them, as Counsellors of State, full power and authority during the period of Her Majesty's absence from the United Kingdom to summon and hold on Her Majesty's behalf Her Privy Council and to signify thereat Her Majesty's approval of anything for which Her

1. It is hereby declared that the governments of the countries specified in the Schedule to this Order have accepted the Safety Convention. 2. It is hereby declared that the Safety Con-vention extends to the territory of the Federation of

Malaya. 3. This Order may be cited as the Merchant Shipping (Safety Convention Countries) (Various) Order, 1954, and shall come into operation upon the date of its publication in the London Gazette.
