WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 7th day of April, 1954, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend (Ronald, Bishop of Leicester (in witness whereof he has signed the Scheme), for effecting the union of the benefice of Somerby and the benefice of Burrough on the Hill, both situate in the diocese of Leicester.

"SCHEME.

"1. *Union of Benefices.* The benefice of Somerby and the benefice of Burrough on the Hill shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Somerby and Burrough on the Hill', but the parishes of the said benefices shall continue in all respects distinct.

"2. *Taking effect of union.*

"(a) If upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette both of the said benefices shall be vacant, the union shall forthwith take effect.

"(b) If upon that day the benefice of Burrough on the Hill shall be full the union shall take effect immediately upon the next vacation thereof and the incumbent (if any) at the relevant date of the benefice of Somerby shall be the first incumbent of the united benefice.

"3. *Parsonage House.* Without prejudice to the exercise, before the date when the union has taken effect, of any of the powers conferred by the Parsonages Measures, 1938 and 1947, the parsonage house at present belonging to the benefice of Somerby shall, if at that date it belongs to the said benefice, be the house of residence of the incumbent of the united benefice and the parsonage house at present belonging to the benefice of Burrough on the Hill, if at that date it so belongs, and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall be sold and disposed of by us after the union has taken effect at such time or times and in such manner in all respects as to us shall seem expedient, and the net proceeds of such sale or sales shall be applied by us as follows, that is to say:—

"(a) so much of the said net proceeds of sale or sales as we, after consultation with the bishop of the said diocese, shall deem sufficient shall be applied towards the cost of the modernisation and improvement of the parsonage house of the united benefice in accordance with plans to be approved by us, or towards the cost of providing or acquiring a new parsonage house for the united benefice, and

"(b) the balance (if any) of the said net proceeds shall be appropriated and held by us for the augmentation of the income of the incumbent of the united benefice.

"4. *Patronage.* Upon the union taking effect the right of presentation to the united benefice shall be exercised by the patrons of the two benefices alternately, the patron of the benefice of Somerby having the first presentation to the united benefice to be made after the union has taken effect."
