The QUEEN's Most Excellent Majesty in Council.

WHEREAS by the Suffragans Nomination Act, 1888, it is enacted, that from and after the passing of that Act for the purposes of the Act of the 26th year of the reign of King Henry the Eighth, Chapter 14, initialed "An Act for Nomination and Consecration of Suffragans within this Paelin" such other Towns of Suffragans within this 'Realm,' such other Towns as Her Majesty The Queen may from time to time by Order in Council direct shall be taken and accepted for Sees of Bishops Suffragans as if they had been included in that Act, and that that Act shall be construed and have effect accordingly:

Now, therefore, Her Majesty, under and by virtue of the powers vested in Her by the said recited Act, and all other powers enabling Her in that behalf, and by and with the advice of Her Privy Council, is pleased to direct, and doth hereby direct, that the Town of which the name is scheduled to this Order, shall be taken and accepted for a See of a Bishop Suffragan as if it has been included in the abovementioned Act of the 26th year of the reign of King Henry the Eighth, Chapter 14.

### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 28th day of June, 1954, in the words and figures following, that is to say:—
"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the houndaries of the parishes of Hornehurch and Rainboundaries of the parishes of Hornchurch and Rainham both in the diocese of Chelmsford.

"Whereas we are satisfied that its desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverand Falkner.

"And whereas the Right Reverend Falkner, Bishop of Chelmsford, consents to the proposed arrangements (in testimony whereof he has signed

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from

and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Hornchurch and Rainham shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

#### "THE SCHEDULE.

"Territory to be transferred to the parish of Rainham:

"All that part (coloured pink on the map annexed hereto) of the parish of Hornchurch which lies to the south-west of an imaginary line commencing at the point on the boundary which divides the parish of Hornchurch from the parish of Dagenham opposite the eastern end of the wall or fence forming the boundary between closes Nos. 625 and 675 and continuing thence southeastwards for a distance of about 25½ chains to a point in the middle of Rainham Road opposite the north-western boundary of close No. 670 the south-western boundary of close No. 670 thereby crossing closes Nos. 764, 583 and 668 and continuing thence south-eastwards to and along the south-western boundary of close No. 670 to its end and thence first north-eastwards and then south-eastwards along the wall or fence which divides close No. 670 from close No. 693 and divides close No. 670 from close No. 693 and continuing thence south-eastwards along the wall or fence forming the south-western boundary of close No. 672 to its end and in a straight line in continuation thereof to a point in the middle of South End Road and continuing thence south-westwards along the middle of South End Road to a point opposite the middle of the footpath leading from the last-mentioned road to Scott's Farm and from the last-mentioned road to Scott's Farm and continuing thence south-eastwards along the middle of the last-mentioned footpath to the wall or fence forming the north-eastern boundary of close No. 725 and continuing thence south-eastwards along the last-mentioned boundary to its end and continuing theme. continuing thence north-eastwards along the north-western boundary of close No. 743 to the north-eastern boundary of the same close and coneastern boundary of the same close and continuing thence generally south-eastwards along the last-mentioned boundary to the north-eastern boundary of close No. 742 and continuing thence south-eastwards along the last-mentioned boundary to its end and continuing thence south-eastwards along the north-western boundary of close No. 738 to the point where it meets the south-eastern boundary of close No. 739A and in a straight line in continuation these 739A and in a straight line in continuation thereof to a point on the boundary which divides the parish of Hornchurch from the parish of Rainham."
