2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 17th January, 1955, to Saturday, the 22nd January, 1955, inclusive, and will be due 91 days after date.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different

5. Tenders must be made through a London Banker, Discount House or Broker.

This Order continues until 18th March, 1956, the existing exemption from duty under the Import Duties Act, 1932, of the iron and steel goods specified in Part II of the Schedule to the Order. The Order also exempts until 18th September, 1955, the iron and steel goods specified in Part II of the Schedule (some of which were previously exempted until 18th March, 1955).

The Order comes into operation on the 14th January, 1955, and has been published as Statutory Instruments 1955 No. 33.
