# UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923.

Statutes made by the Governing Body of King's College, in the University of Cambridge, on the 12th February, 1955, have been submitted for the approval of Her Majesty in Council, and notice of their having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act, 1923.

#### TENDERS FOR TREASURY BILLS.

1. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and pay-ment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Satur-day, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
