## DANGEROUS DRUGS REGULATIONS, 1953. CANCELLATION OF SUSPENSION OF WITHDRAWAL OF AUTHORISATION.

## (Joseph Anatole France Tobin.)

(Joseph Anatole France Tobin.) Whereas the authorities, respectively conferred by the Dangerous Drugs Regulations, 1937, and the Raw Opium, etc., Regulations, 1937, on Joseph Anatole France Tobin, M.R.C.S., L.R.C.P., by virtue of his being a duly qualified medical practitioner to be in possession of and to supply the drugs and prepara-tions to which those Regulations applied were, the said Joseph Anatole France Tobin having been con-victed of offences against the Dangerous Drugs Acts, 1920 to 1932, withdrawn in pursuance of the powers conferred on the Secretary of State by Regu-lation 7 of the first mentioned Regulations by Notice published in the London Gazette and the Edinburgh Gazette on the 16th July, 1943, the regis-tered address of the said Joseph Anatole France Tobin being then 82, Windsor Road, Forest Gate, London, E.7.
