The QUEEN has been graciously pleased on the advice of Her Majesty's Australian Ministers, to approve the award of the George Medal to:—

On the 17th March, 1957, in the Mount Royal area a Sapper was operating an hydraulic angle dozer clearing trees on a road deviation, when a large branch fell from one of the trees knocking him unconscious. The dozer, out of control, knocked the tree down, rode across the large upended stump and continued down a precipitous hill, still with the tree trunk between its tracks. Lance Corporal Eggington saw the accident and without any hesitation and with complete disregard without any hesitation and with complete disregard for his own personal safety, immediately attempted to climb aboard the dozer. As the dozer mounted the upended tree stump EGGINGTON was thrown off and injured his leg. Disregarding his injury he again attempted to mount the dozer. Despite the again attempted to mount the dozer. Despite the hazard of the power control unit with its spinning drums of cable, he succeeded in reaching the driver's seat, threw out the master clutch and thus stopped the machine. He then lifted the unconscious driver from the dozer and both men were taken to hospital. Lance Corporal Eggington's courageous action, performed at such personal risk and pursued even after receiving severe injuries himself, undoubtedly saved the Sapper from death or disablement.

## TENDERS FOR TREASURY BULLS.

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 11th October, 1957, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £260,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 14th October, 1957, to Saturday, the 19th October, 1957, inclusive, and will be due 91 days after date.

3 The Bills will be issued and paid at the Bank of England.
