#### FACTORIES ACT, 1937

The Minister of Labour and National Service hereby gives notice that on 22nd April 1959, he made the Employment of Young Persons (Iron and Steel Industry) Regulations, 1959, under section 81 of the Factories Act, 1937. The purpose of this Order is to modify the condition in section 81 (2) (c) of the Factories Act, 1937, that no male young person shall be employed between midnight and 6 a.m. in two consecutive weeks.
