

instrument (not being a fixed engine) other than a lave net, tuck net or rod and line, except that a landing net or a gaff or tailer may be used as auxiliary to angling with a rod and line, and a casting tread or dip net may be used for catching fish for bait.

Consequential Revocation of Existing Byelaws

From the date of confirmation of the above Byelaws by the Minister of Agriculture, Fisheries and Food, the Byelaws numbered 8A, relating to the use of maggots as bait, and 12, relating to the prohibition of night lines, etc., made by the River Board and confirmed by the Minister of Agriculture, Fisheries and Food, on the 3rd day of

January 1957, and the 21st day of October 1953, respectively, are hereby revoked.
