PRESENT.

The QUBEN'S Most Excellent Majesty in Council.

Whereas the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 7th day of May 1959, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Falkner, Bishop of Chelmsford (in witness whereof he has signed this Scheme), for authorising the sale of the site of the former parish church of All Saints, Squirrels Heath, in the diocese of Chelmsford.

"Whereas the former parish church of All Saints, Squirrels Heath, was destroyed by enemy action, and a new church has been erected upon another site within the same parish and has been duly consecrated:

"And whereas by Instrument under our Common Seal dated the 8th day of January 1958, we, the said Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, declared that the said new church should be substituted for the former parish church:

"Now, therefore, we, the said Church Commissioners, do humbly recommend and propose to Your Majesty in Council as follows, that is to say:

"1. As soon as conveniently may be after the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the site of the former parish church of Gazette the site of the former parish church of All Saints, Squirrels Heath, together with any land annexed or belonging thereto, shall be sold and disposed of by us at such time or times and in such manner in all respects as to us shall seem expedient, subject to the conditions and restrictions imposed by the said Union of Benefices Measures.

"2. The net proceeds to arise from such sale or sales, after payment of the expenses attendant thereon, shall be placed to the credit of the Expenses Fund of the diocese of Chelmsford established pursuant to the 32nd section of the Union of Benefice Measure, 1923.

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:
