#### TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, 12th February 1960, at 1 p.m.

2. (The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 15th February 1960 to Saturday the 20th February 1960, inclusive and will be due 91 days

after date. 3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must be ton an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

The Import Duty Drawbacks (No. 1) Order, 1960, which reduces the rate of drawback of import duty on specified descriptions of imported aluminium foil used in the manufacture of certain exported metallic yarn, and describes more appro-priately both the imported materials and the exported goods.

The Order comes into operation on the 8th February 1960, and has been published as Statutory Instruments 1960, No. 157.
