## ROYAL TUNBRIDGE WELLS BOROUGH COUNCIL

*The Borough of Royal Tunbridge Wells (Victoria Road and Goods Station Road) (Traffic Regulation) Order, 1962.*

Notice is hereby given that on the 3rd day of October 1962 the Royal Tunbridge Wells Borough Council made an Order under sections 26 and 27 of the Road Traffic Act 1960, the effect of which will be to prohibit waiting from 8 a.m. until 6 p.m., on the following lengths of road:

- (1) The northern side of the whole of the length of Victoria Road Tunbridge Wells, between its junction with Camden Road and its junction with Goods Station Road.
- (2) The southern side of the whole of the length of Victoria Road Tunbridge Wells between its junction with Camden Road and a point opposite the westerly boundary of 69 Victoria Road.
- (3) The north west side of that length of Goods Station Road, Tunbridge Wells, as lies between its junction with Meadow Road and a point 45 feet north east of the junction with Victoria Road.
- (4) The south eastern side of that length of Goods Station Road, Tunbridge Wells, as lies between its junction with Victoria Road and a point 45 feet north east of that junction.

The Order will contain exceptions permitting the picking up and setting down of passengers, the loading and unloading of goods, the taking in of petrol, oil, water or air from any garage and access for the maintenance of the normal services of the road.

## ROYAL TUNBRIDGE WELLS BOROUGH COUNCIL

*Borough of Royal Tunbridge Wells (Queens Road, Newcomen Road, John Street and Culverden Down) (Traffic Regulation) Order, 1962.*

Notice is hereby given that on the 3rd day of October 1962 the Royal Tunbridge Wells Borough Council made an Order under sections 26 and 27 of the Road Traffic Act 1960, the effect of which will be to prohibit waiting from 8 a.m. until 6 p.m., on the following lengths of road:

- (1) Both sides of that length of Queens Road, Tunbridge Wells as lies between its junction with St. John's Road and a point 45 feet east of that junction.
- (2) Both sides of that length of Newcomen Road, Tunbridge Wells, as lies between its junction with St. John's Road and a point 45 feet east of that junction.
- (3) Both sides of that length of John Street, Tunbridge Wells, as lies between its junction with St. John's Road and a point 45 feet west of that junction.
- (4) Both sides of that length of Culverden Down, Tunbridge Wells, as lies between its junction with St. John's Road and a point 45 feet west of that junction.

The Order will contain exceptions permitting the picking up and setting down of passengers, the loading and unloading of goods, the taking in of petrol, oil, water or air from any garage and access for the maintenance of the normal services of the road.

## ROYAL TUNBRIDGE WELLS BOROUGH COUNCIL

*The Borough of Royal Tunbridge Wells (Warwick Park) (Traffic Regulation) Order, 1962.*

Notice is hereby given that on the 3rd day of October 1962 the Royal Tunbridge Wells Borough Council made an Order under sections 26 and 27 of the Road Traffic Act 1960, the effect of which will be to prohibit waiting for a longer period than 30 minutes from 8 a.m. until 6 p.m. on the following lengths of road:

- (1) The north easterly side of that length of Warwick Park, Tunbridge Wells as lies between the existing northerly limit of the street parking place (authorised by the Borough of Royal Tunbridge Wells (Parking Places) Order, 1962) and a point 144 feet north north west thereof.
- (2) The south westerly side of that length of Warwick Park, Tunbridge Wells as lies opposite the existing northerly limit of the said street parking place and a point 87 feet north north west thereof.

The Order will contain exceptions permitting the picking up and setting down of passengers, the loading and unloading of goods, the taking in of petrol, oil, water or air from any garage and access for the maintenance of the normal services of the road.

The Order will also revoke the Borough of Royal Tunbridge Wells (Warwick Park) (Traffic Regulation) Order, 1955, as amended by the Borough of Royal Tunbridge Wells (Variation of Waiting) (Traffic Regulation) Order, 1958, in so far as it relates to the above mentioned lengths of road.
