

## DORSET COUNTY COUNCIL

*The County of Dorset (Various Streets, Swanage)  
(Prohibition of Waiting and Unilateral Waiting)  
(No. 2) Order, 1963.*

Notice is hereby given that the Dorset County Council propose to make an Order under section 26 of the Road Traffic Act, 1960, the effect of which will be to impose the undermentioned restrictions on roads in the Urban District of Swanage:

(A) To apply the existing waiting restrictions in the undermentioned roads for 24 roads each day during the period 1st May to 30th September inclusive in each year and between 8 a.m. and 8 p.m. during the period 1st October to 30th April inclusive;

*High Street  
Institute Road  
Station Road.*

(B) To amend the existing waiting restrictions in Kings Road East so as to prohibit waiting for 24 hours each day during the period 1st May to 30th September inclusive in each year and between the hours of 8 a.m. and 8 p.m. during the period 1st October to 30th April inclusive.

(i) on both sides between its junction with Eldon Terrace and its junction with Kings Road West, and

(ii) on its south-western side between its junction with Eldon Terrace and its junction with High Street.

(C) To impose the undermentioned additional restrictions:

(i) *Prohibition of Waiting: Between 8 a.m. and 8 p.m. throughout the year:  
Mermond Place*

(ii) *Prohibition of Waiting: Between 8 a.m. and 8 p.m. 1st May to 30th September inclusive:*

*Gilbert Road: on its northern side between its junctions with Ilminster Road and Rempstone Road.*

*Beach Gardens: on the whole of its southern side.*

*Cauldron Avenue: on the whole of its northern side.*

*Clifton Road: on the whole of its northern side.*

*Seymer Road: between its junctions with Belvedere Road and Park Road.*

(iii) *Unilateral Waiting: Between 8 a.m. and 8 p.m. 1st May to 30th September inclusive.*

*Ilminster Road.  
Cranborne Road.  
Gannets Park.  
Battlemead.  
Vivian Park.*

(iv) *Limited Waiting: 20 minutes in any hour for 24 hours each day 1st May to 30th September inclusive and between 8 a.m. and 8 p.m., 1st October to 30th April inclusive.*

*Institute Road: on its western side, between a point 36 feet south of its junction with Station Road and a point 110 feet south of that junction.*

The Order will contain certain exceptions to permit passengers to board or alight from a vehicle, to enable goods to be loaded or unloaded or to enable a vehicle to be used in connection with building or demolition work, the removal of obstructions from the roads or any work in connection with public services in the roads.

*The County of Dorset (High Street, Swanage)  
(One-Way) Order, 1963*

Notice is hereby given that the Dorset County Council propose to make an Order under section 28 of the Road Traffic Act, 1960, the effect of which will be to impose a system of one-way traffic in High Street, Swanage, between the western side of its junction with Stafford Road and the eastern side of its junction with Court Hill, in which length traffic

will be permitted to proceed only in the direction from east to west.

The Order will be in operation for a period not exceeding three months from the date of its commencement, unless the Minister of Transport authorises an extension thereof.

*The County of Dorset (Studland) (Prohibition of Waiting) Order, 1963*

Notice is hereby given that the Dorset County Council propose to make an Order under section 26 of the Road Traffic Act, 1960, the effect of which will be to prohibit the waiting of vehicles at all times between 1st June and 30th September each year in the length of Unclassified County Road at Studland from the southern side of the Bankes Arms Hotel, south-eastwards, southwards and south-westwards for a total distance of 260 yards.

The Order will contain exceptions to permit passengers to board or alight from a vehicle, to enable goods to be loaded or unloaded or to enable a vehicle to be used in connection with building or demolition work, the removal of obstructions from the road or any work in connection with public services in the road.

## BRIGHTON COUNTY BOROUGH

*The Brighton Corporation (St. George's Road—  
B.2118) (Unilateral Waiting) Order, 1963*

Notice is hereby given that on the 26th day of April 1963, the Brighton County Borough Council made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is, between the hours of 8 a.m. and 6 p.m. on any weekday, to prohibit waiting in St. George's Road (B.2118) on the south side from a point 15 feet east of the eastern kerblines of Bloomsbury Street to the western kerblines of Abbey Road and on the northside from a point 100 feet east of the eastern kerblines of Paston Place to its junction with Eaton Place and to limit waiting to 30 minutes in any hour on the side of the road on which waiting is not prohibited.

The Order contains the usual provisions permitting vehicles to wait for persons to board or alight or goods to be loaded or unloaded or the vehicles to be used in connection with any building operation or demolition, the removal of any obstruction to traffic or the maintenance of the roads or the services therein and comes into force on the 13th day of May 1963.
