Godstone Rural District (Footpath No. 451 Burstow) Diversion Order 1962

Notice is hereby given that R. F. F. Williams, Esq., G.M., A.M.I.Mun.E., M.T.P.I., will attend a local inquiry to be held at the Women's Institute Hall, Burstow, near Horley, Surrey, on Thursday 12th September 1963, at 10.30 a.m. for the purpose of hearing objections to the Minister's proposal to make an Order under section 112 (5) of the Highways Act 1959.

The effect of the Order if made by the Minister would be to divert part of footpath No. 451 which leads from a point to the west of Shipley Bridge in a northerly direction to Church Lane, being the part which commences at St. Audrey's Cottage, Green Lane and extends in a northerly direction for approximately 280 yards to its junction with Church Lane, to a line commencing at St. Audrey's Cottage and proceeding eastward along the existing private road known as Green Lane for a distance of approximately 175 yards to "St. Audrey" and thence northward for a distance of approximately 300 yards to the junction of Green Lane with Church Lane at "Old Orchard".
