

RATES OF INTEREST ON LOANS FROM THE
LOCAL LOANS FUND

The Treasury, in pursuance of the powers conferred on them by the Public Works Loans Act 1964, hereby give notice that on and after 27th February 1964 the following rates of interest shall be charged on loans made out of the Local Loans Fund.

Loans to local authorities as defined by section 10 of the Local Authorities Loans Act 1945:	5½

(a) The rates of interest at I above will also apply in the following circumstances:

- (i) Loans under the Harbours and Passing Tolls, etc. Act 1861, with collateral security;
- (ii) Loans under the Housing (Financial Provisions) Act 1958 and the Housing (Scotland) Act 1950 to companies and private persons limiting their profits to 5 per cent. per annum;
- (iii) Loans to housing associations as defined by the Housing Act 1957 and the Housing (Scotland) Act 1950.

(b) The rates of interest at I above plus ¼ per cent. will apply in the following circumstances:

- (i) Loans under the Harbours and Passing Tolls, etc. Act 1861, without collateral security;
- (ii) Loans under the Housing (Financial Provisions) Act 1958 and the Housing (Scotland) Act 1950 to companies and private persons not limiting their profits to 5 per cent. per annum.
