# Waiting Restrictions

### Urban District of Brentwood

The Minister of Transport proposes to make Regulations under the Road Traffic Act, 1960, as amended:

- 1. to restrict waiting by vehicles between 8 a.m and 8 pm. on Mondays to Saturdays inclusive m:
  - Hutton Road north side, between a point 190 feet north-east of the north-eastern flank wall on Nos 3 Station Terrace and Rayleigh Road;
  - Rayleigh Road north side, between Hutton Road and the boundary between Nos. 32-34 Rayleigh Road and including the northern arm extending to Alexander Lane;
  - 3 Alexander Lane south-east side from Rayleigh Road north-eastward for 140 feet;
- 2. to limit waiting, during the same hours, to two hours in any four hours in Hutton Road in five lay-byes situated:
  - (a) on north side
    - (1) each side of its junction with Crossways;
  - (ii) between Station Terrace and the Railway Bridge; and
  - (b) on south side each side of its junction with Friars Avenue.

Exemptions would be provided in the Regulations to permit vehicles to wait in order to pick up and set down passengers, to load and unload goods, to carry out essential services, or when used by local authorities in pursuance of statutory powers or duties.

# Waiting Restrictions Urban District of Sunbury

The Minister of Transport proposes to make Regulations under the Road Traffic Act, 1960, as amended, to restrict waiting by vehicles at all times in:

- (a) Green Street from Thames Street north-westward for 180 feet;
- (b) Thames Street between the north-east side of French Street and the south-west side of Green Street;
- (c) The access road to Clark's Wharf between its junctions with Thames Street opposite No. 53, and opposite No. 69 Thames Street,

and in the first 45 feet of all adjoining side roads

(Note: restrictions on waiting in some of these parts of road already apply from 8 30 a.m. to 6.30 pm on Mondays to Saturdays inclusive)

# Waiting Restrictions Urban District of Feltham

The Minister of Transport proposes to make Regulations under the Road Traffic Act, 1960, as amended:

- (1) to restrict waiting by vehicles between 8 30 a m and 6 30 p.m. on Mondays to Saturdays inclusive in the parts of road specified in the Schedule hereto;
- (2) to limit waiting by vehicles to twenty minutes in any period of forty minutes between 8 30 a m. and 6 30 p.m. on Mondays to Saturdays inclusive, in the lay-by on the north-west side of Staines Road opposite Nos. 537-539 Staines Road

# The Experimental Traffic (Various Roads) (Acton) (Amendment) Order, 1965

The Minnster of Transport hereby gives notice that he intends to make an Order under sections 28 and 48 of the Road Traffic Act 1962, the effect of which will be to amend the Experimental Traffic (Various Roads) (Acton) Order 1964 so as to prohibit the making of "U" turns by vehicles passing through the gaps in the central reservation an Western Avenue:

- (a) Opposite its junctions with:
  - (1) Allan Way
  - (a) Court Way
  - (111) Park View.
- (b) 190 feet south-east of its junction with Victoria Road
