TENDERS FOR TREASURY BILLS

TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 5th November 1965, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £180,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 8th November 1965, to Saturday

the 13th November 1965, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

Reference to the National Board for Prices and Incomes

Claims for Increased Pay, a Shorter Working Week and other Improved Conditions of Service for British Railways Shopmen

Negotiations have been taking place between the British Railways Board and the Employees' Side of the Railway Shopmen's National Council on claims for increased pay, a shorter working week and increased holidays for railway workshop staff. These negotiations have not resulted in agreement.

In view of the importance of these claims for the national interest and the fact that the workshop staff national interest and the fact that the workshop staff form part of the railway industry, the Government have decided that the issues in dispute relating to workshop staff should be examined by the National Board for Prices and Incomes on the same terms and subject to the same understandings with the parties as in the case of salaried and conciliation staff.

The Board is accordingly requested to extend its investigation of the issues in dispute relating to conciliation and salaried staff to cover those relating to workshop staff.
