THE SOUTHERN RHODESIA (PETROLEUM) (IMPORTATION OF LUBRICANTS FOR RHODESIA RAILWAYS) REGULATIONS, 1966

In exercise of the powers in that behalf conferred on me by article 3 of the Southern Rhodesia (Petroleum) Order, 1965, I, Arthur George Bottomley, one of Her Majesty's Principal Secretaries of State, make the following Regulations:

- These Regulations, which may be cited as the Southern Rhodesia (Petroleum) (Importation of Lubricants for Rhodesia Railways) Regulations, 1966, shall come into operation forthwith and shall be published in the *London Gazette* as soon as may be after they have been made.
- (1) Subject to the limitation specified in paragraph (2) of this regulation, there is hereby authorised—
 - the importation into Southern Rhodesia by or on behalf of Caltex Oil (S.A.) Ltd. (hereinafter referred to as the Company) of the products set out in the first column of the Schedule hereto for the use of the Rhodesia Railways;
 - the acceptance by any person acting on behalf of the Company of delivery of any such products aforesaid which such person intends, or which he has reason to believe that the Company or some other person acting on its behalf intend, to import into Southern Rhodesia under the authority of the immediately preceding subparagraph; and
 - the making or carrying out of any contract providing for such importation or delivery.

- The total quantity of each of such products aforesaid which may be imported into Southern Rhodesia in any one calendar month under the authority of this regulation shall not exceed the quantity set out opposite such product in the second column of the Schedule hereto.
- The products authorised to be imported by regulation 2 are described by their commercial names, and the authority thereby conferred is restricted to products so described as compounded in accordance with the specifications in use for the manufacture of such products at the time these Regulations come into operation.
