#### UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the University of Oxford, on the 13th June 1966, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

### ROYAL WARRANT

Whereas We deem it expedient to make further provision concerning the pensions and associated benefits for certain members of the former Indian and Burma Armed Forces specified in the Fourth Schedule to Our Warrant of 21st May 1955, Cmnd. 9362.

Our Will and Pleasure is that:

1. There shall be applied to the persons referred to in the Fourth Schedule to Our Warrant of 21st May 1955, the provisions of Our Warrant of 19th September 1964, Cmnd. 2467 (as amended by Our Warrants of 15th December 1964, Cmnd. 2553, 18th February 1966, Cmnd. 2926, and 27th May 1966, Cmnd. 3023) as it applies to or in respect of the forces and services referred to therein.
2. Any general improvements in disability awards and connected allowances provided by Our Warrants subsequent to that of 8th January 1955, which are specified in the Ninth Schedule to Our said Warrant of 19th September 1964, and by Our said Warrant of 19th September 1964, as amended by Our said Warrants of 15th December 1964 and 18th February 1966, and which have been afforded prior to the date of this Our Warrant to officers and dependants specified in the Fourth Schedule of Our Warrant of 21st May 1955, are confirmed.
3. Any benefit granted under this Our Warrant may be withheld or reduced if the officer, his widow or children, are in receipt of overlapping awards from the Ministry of Pensions and National Insurance by the amount of that award. Provided that, in so far as any benefit granted under Our said Warrant of 19th September 1964, as applied by this Warrant which might have been granted to or in respect of officers or soldiers who served with or as part of the former Armed Forces of Burma under any Warrant made up to and including the date of Our Warrant of 4th December 1943, if those Warrants had continued to apply to or in respect of other persons referred to in the Fourth Schedule of Our Warrant of 21st May 1955, under any Warrant made up to and including the date of
