A Statute made by the University of Cambridge, on the 22nd December 1966, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

PUBLIC SCHOOLS ACT, 1868

THE GOVERNING BODY OF ETON COLLEGE having on the 12th day of December 1966, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending Statute XXV of the existing Statutes of the said College, the said Statute is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act.

And notice is hereby given, that any person, body of persons, or body corporate, authorised in that behalf by the said Act, may, within two months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

STATUTE made by the Governing Body of Eton College on the 12th day of December 1966.

STATUTE to alter and amend the Statutes of Eton College which amending Statute having been duly made at a Meeting held at Eton on the 12th day of November 1966, of the Provost and Fellows of Eton College (the said Provost and Fellows being the new Governing Body of the said College for the purposes of the Public Schools Act 1868 and the Acts amending the same) and passed at such Meeting by a majority of votes of the Members present and voting is now submitted for the approval of Her Majesty in Council.

We, the Provost and Fellows of Eton College being the new Governing Body of the said College (hereinafter called "the College") for the purposes of the Public Schools Act 1868 and the Acts amendor me rubic Schools Act 1808 and the Acts amending the same in pursuance of the power given to us by the Eleventh Section of the Public Schools Act 1868 (and of all other powers us hereunto enabling) to alter the Statutes made under that Act and the Acts amending the same in relation to the College do hereby amend the Statutes of the College as follows: follows:

(A) By deleting Clauses (1) and (4) of Statute XXV and substituting in lieu thereof

"(1) The Scholarships and Exhibitions known as the "Reynolds" "Bryant" "Davies" and "Chamberlayne"—together with that founded by Dr. Berriman in 1750, increased by Mr. Hetherington in 1770, further increased by Dr. Davies in 1809 and consolidated under the name of the "Berriman Exhibition"—shall be offered for cornnection to all senior boys in the School for competition to all senior boys in the School whether Foundation Scholars or Oppidans"

(B) By deleting Clauses (2) and (3) of Statute XXV and adding the following new clauses to Statute XXV that is to say:

"(2) The Scholarships and Exhibitions referred to as Donative Exhibitions and known as the "Dayles Headmaster" "Richards" "Dr. Goodall" "Miss Goodall" and "Goodall Statute" shall be open to all boys in the School whether Foundation Scholars or Oppidans with out competitive examination

(3) These Scholarships and Exhibitions shall

(3) These Scholarships and Exhibitions shall be awarded by the Provost on the recommendation of the Head Master to boys proceeding to any University or place of further education (4) The number of awards to be made in any year from each of these funds, the amount payable to each scholar or exhibitor, and the duration of each award, shall be determined by the
