The QUEEN has been graciously pleased on the advice of Her Majesty's Jamaica Ministers to approve the undermentioned award:

Air Force Cross

(temporary Major) Robert James NEISH Captain (JCA/1007), Jamaica Defence Force.

On Tuesday, 16th May 1967, a Fusilier of 1st Bn XX The Lancashire Fusiliers, in Jamaica on Exercise Calypso Hop, fell and injured his back whilst training at an altitude of 6,500 feet in the Blue Mountains. The Unit Medical Officer diagnosed a broken back and ordered that the Fusilier be lifted out in a horizontal position. A decision was made to try and lift him out by helicopter the following morning.

The Fusilier was lying on the edge of a small clearing surrounded by tall trees, on the side of a valley with extremely steep sides and 400 feet below a col at the head of the valley. There was inter-mittent cloud and winds of up to 25 m.p.h. were blowing up the side of the valley and over the col. The bottom of the valley was 1,500 feet below the injured man.

In order to place the Fusilier on to the stretcher, fixed to the right runner of the helicopter, it was necessary to position the helicopter near enough to the side of the mountain to put the right runner on the ground. However, measurements made by those on the ground proved that due to the steepness of the on the ground proved that due to the steepness of the mountain the tip of the helicopter rotor would hit the mountain before the runner was near enough to allow the Fusilier to be lifted on to the stretcher, let alone place the runner on the ground. Major R. J. Neish, Officer Commanding the Jamaica Defence Force Air Wing, and pilot of the helicopter, gave instructions Wing, and phot of the helicopter, gave instructions by radio from the helicopter, to those on the ground, to build a platform in the centre of the clearing, thus enabling the injured man to be brought further out from the side of the mountain. He gave further instructions for a section to be dug out of the side of the hill to accommodate the tip of the rotor. Returning on the afternoon of 17th May when the work had been done Major Najob was informed that

work had been done, Major Neish was informed that when the runner of the helicopter was on the plat-form, the tip of the rotor would be about 3 to 6 feet from the mountain and there would be a bolt 5 to 6 teet from the mountain and there would be a gap of 2 to 4 feet underneath the rotor. He was also informed that the platform was not strong enough to take the weight of the helicopter. Major Neish knew well that despite having one runner on the platform the sudden extra weight of the casualty being placed on the helicopter's stretcher would alter the centre of gravity of the helicopter and might cause it to crash. The Fusilier had now been lying on the

it to crash. The Fusilier had now been lying on the side of the mountain for 30 hours. Using another pilot as a crewman to assist him, Major Neish decided to try to lift out the Fusilier. At the first attempt he placed the front of the right runner on to the platform, the left runner being in mid air. A turbulent and gusty wind was blowing, making it extremely difficult for the pilot to control the helicopter. Major Neish slowly edged the heli-copter into position until the end of the rotry was copter into position until the end of the rotor was four feet from the mountain and there was only two

to three feet underneath the rotor. At the pre-arranged signal those on the platform lifted the Fusilier on to the helicopter stretcher. Unfortunately he was placed too near the rear of the stretcher. This altered the centre of gravity of the helicopter and the tail rotor, despite maximum correction by Major Neish, started to drop down into the valley below the patform. The Fusilier was immediately taken off the helicopter's stretcher and just in time Major Neish regained control and took off hereing the converte control and took

just in time Major Neish regained control and took off, leaving the casualty on the platform. After circling for several minutes and giving further instructions over the radio to the ground party, Major Neish made a second attempt. Due to the difficult conditions and despite every effort of those on the platform the casualty was again placed too near the rear of the stretcher, thus again unbalancing the heli-copter and causing it to go into and out of centre of gravity condition. This time there was neither suffi-cient time to lift off, nor tie on, the casualty and cient time to lift off, nor tie on, the casualty, and the imbalance of the helicopter was further aggra-vated by the necessity for the crewman to lean out of the helicopter and hold the casualty on to the stretcher. The helicopter was now outside of control limits and it immediately started to back away from the platform and turn to the right inside the confine

of the narrow valley. The controls were as far left and forward as they would go. Due to this con-dition the helicopter would only fly in a right-handed circle and it would no longer hover. By flying in continuous right-handed circles of varying diameters within the narrow valley Major Neish managed to reach a height of nearly 8,000 feet, enabling him to clear the Blue Mountains. By continuing to fly in right-handed circles he eventually landed some 10 miles away on a football pitch, where it was possible to make a running landing. The casualty was then tied in and flown safely to hospital. Throughout the whole performance Major Neish showed a degree of courage, skill, concentration and judgment far in excess of that normally required of the pilot of a beliconter

The QUBEN has been graciously pleased on the advice of Her Majesty's Jamaica Ministers to approve the undermentioned award:

Queen's Commendation for Valuable Services in the Air

Lieutenant Andrew Anthony BOGLE (JCA/1029), Jamaica Defence Force.

On 17th May 1967, Lt. A. A. Bogle, a helicopter pilot of the Air Wing of the Jamaica Defence Force acted as crewman in a three-man helicopter on a casualty evacuation task in the Blue Mountains. The casualty, a Fusilier of 1st Bn XX The Lan-cashire Fusiliers, had to be evacuated in a prone position on a stretcher fitted to the outside of the helicopter.

The casualty had to be rescued from a clearing in a narrow valley at an altitude of 6,500 feet on the side of a steep mountain.

Due to the steep mountain. Due to the steepness of the mountain the helicopter could not be landed. Instead, only one runner could be placed on the edge of a platform, constructed on the side of the mountain. It was from this platform that the casualty was to be lifted on to the stretcher which was fitted to the right runner of the helicopter. Conditions were such that the casualty was placed too far to the rear of the stretcher. This resulted in the Conditions were such that the casualty was placed too far to the rear of the stretcher. This resulted in the helicopter going into an out of centre of gravity con-dition and despite maximum correction by the pilot it started to fly backwards and to the right, away from the platform, in what was now a semi out of control state. This happened so quickly that there was neither time for those on the platform to take the casualty off the stretcher nor to strap him in. Lt. Bogle, himself a pilot, realising that the casualty might fall off the stretcher into the valley below and that the helicopter was in a semi out of control state, immediately undid his seatbelt, got out of the right side of the helicopter and held the casualty into the stretcher. By altering his position Lt. Bogle fully appreciated that he would make the imbalance of the helicopter even worse, that it would tilt even more to the right and increase further the chances of an incident. The pilot, however, managed to regain partial control and by flying in right-handed circles of varying diameter at altitudes approaching as much as 8,000 feet he managed to land 10 miles away on a football pitch. Throughout this journey Lt. Bogle remained half out of the helicopter and only held in by his right hand whilst he held the injured man on the stretcher with his left head. Throughout Lt. Bogle remained half out of the helicopter and only held in by his right hand whilst he held the injured man on the stretcher with his left hand. Throughout the flight the helicopter was tilted to the right thus aggravating the tendency to tip the casualty off the stretcher and Lt. Bogle out of the helicopter. Lt. Bogle undoudtedly saved the life of the Fusilier. Throughout the rescue, Lt. Bogle, fully aware of the hazards involved, showed an outstanding degree of judgment and courage, and acted with almost complete disregard to his own personal safety.
